



## 2025 Make Tax Time Pay Clinics

**Note: Information current as of February 10, 2025.**  
**Clinic information updated weekly on Mondays and subject to change.**

To be eligible for Make Tax Time Pay supports, a household or family's income must be below the following thresholds:

Family Size	Total Family Income
1 person	\$35,000
2 people	\$45,000
3 people	\$47,000
4 people	\$50,000
5 people	\$52,000
More than 5 people	\$52,500 plus \$2,500 for each additional person

Our volunteer tax preparers **cannot** file for the following situations:

- Self-employment, business contractor, or freelance income
- Gig or Sharing Economy Employment including income from Uber, Uber Eats, Skip the Dishes, DoorDash, etc.
- Rental or property income
- Foreign property or income
- Farming or fishing income
- Capital gains or losses
- Bankruptcy
- Deceased individuals or estates
- Interest income exceeding \$1,000

***These and other complex situations require an accountant.***

Eligible low-income tax filers are welcome to drop in to any of the tax clinics listed below. It is recommended to arrive early, as clinics will stop accepting walk-ins when they reach full capacity. All clinics work on first come first served basis only. **If tax filers need to file their taxes as a family, both partners must be present at the clinic.**

**Alternatively, we have a limited amount of phone appointments available for individuals who have barriers in attending one of our in-person clinics throughout Edmonton and Sherwood Park. Bookings for phone filing appointments can be made from February 26<sup>th</sup> by calling 780-722-9409. We will book appointments for the current week. Once those are full, we'll start booking for next week on the following Monday.**

Those looking to file their taxes should bring the following with them:

- Government ID (required)
- Social Insurance Number (required)
- Bank account or direct deposit information (if setting up direct deposit)
- Tax slips including: T4s, T4E, T4A, T4RIF, T4RSP, T5, T5007, T2202 (if available)



- Receipts for: Charitable donations, medical and dental expenses, childcare, RRSP contributions (if available).

## Super Clinics

Super Clinics include services and supports from Service Canada and the Canada Revenue Agency (CRA) outreach team.

Service Canada will supply information and support regarding the following:

- Employment Insurance
- Canada Pension Plan
- Old Age Security
- Social Insurance Numbers

- Address and Phone Number changes
- Information on credits and benefits
- Understanding CRA communication
- Information on Canada Child Benefit
- Information on the Disability Tax Credit
- Information on the Canada Revenue Agency
